Respectfully represents: That he is a native of *Italy*; that he has resided in the United States of America three years next preceding his arriving at the age of twenty-one years, and continued to reside therein to the time of making this application, and has resided in the United States continuously for five years at least, and that he has resided in the State of Pennsylvania one year at least, previous to making this application; that he is now twenty-one years of age and upwards; that he does not disbelieve in, nor is he opposed to, all organized government; that he is not a member of, or affiliated with, any organization entertaining and teaching such disbelief or opposition; that he does not advocate or teach the duty, necessity or propriety of the unlawful assaulting or killing of any specific individual, or of officers generally, of the Government of the United States or of any other organized government, because of his or their official character; and that he has not violated any of the provisions of an Act of Congress entitled "An Act to regulate the Immigration of Aliens into the United States," approved March 3, 1903. He therefore prays your Honor to admit him to become a citizen of the United States of America agreeably to the Act of Congress in such case made and provided.

An now, to wit, this *5* day of *October* 190*4*, careful inquiry having been made into the matter of said application for naturalization, and it appearing that all the requirements of the Act of Congress entitled "An Act to Establish a Uniform Rule of Naturalization," etc., passed April 14, 1802, and the Acts subsequently passed on that subject, and of the Act of Congress entitled "An Act to regulate the Immigration of Aliens into the United States," approved March 3, 1903, have been complied with, the applicant appearing personally in Court and producing such evidence and affidavits of himself and his witness and making such renunciations and taking such oaths as are by said Acts required, the affidavit of said applicant and witness being duly made and recorded, it is ordered that the said *Dante Gattiero* be, and he is, admitted a citizen of the United States.
